

- This online course is very strong on the subject of active listening to musical forms and structures. It does not meet the course content of MUS 100- Music Appreciation with regards to identification of instruments or a survey of music history and literature.
- Textbooks for this course typically include a survey of musical materials and vocabulary, an introduction to
 musical instruments of the orchestra, an introduction to musical forms, and a survey of music history and
 literature from the 14th Century to the present. Stronger volumes would include ample musical scores
 and access to recordings of those examples.
- This book includes audio examples imbedded in the text but fails to address many other content issues for this course.
