

The text will be demanding for students and is extremely extensive in its coverage of topics; indeed, if anything, perhaps overly so @ 940 pages. I would probably need to drop at least two chapters which would be difficult since materials are outstanding. Numerous exercises/problems, cases, summaries, introductory cases. Particularly liked the "ethics" angle of many of the problems & exercises.
- Exploring Business was linked to a course platform. The platform provided extensive supplemental materials.
